#### IGNORANCE IS NOT BLISS

Missouri 811 is the notification center. However, there is a greater morality than just sending messages that someone is going to dig around your utilities. There is a responsibility to help utilities and excavators alike understand the laws, rules, the standards of practice, and understand

that in our lives "Ignorance may not necessarily be bliss" in the opposite spirit of the old saying.

There is so much to your day-to-day life as a utility. You are trying to get that water line laid or repaired, broadband to new customers, gas and electric service to customers that need to use energy to make their day happen...but underlying all of that is the need to understand the crowded world of underground utilities, the laws, the rules, the standards of practices...and the understanding of the consequences of not knowing.

This issue of the newsletter talks about training. #### 50-IN-5

Beginning in 2023, Missouri 811 has been on a mission to cut utility damages by 50% by 2028. This is a big goal, and because of that, we need everyone's help in reducing damages across Missouri. It is estimated that damages to national underground utilities cost \$30 billion annually.

Of these damages, we know that over 76% are caused by:

- Failure to notify 811
- · Failure to pothole, maintain clearance, etc.
- · Failure to accurately or failure to complete locates in a timely manner

Missouri 811 believes that with the help and participation of our excavators, utility providers and homeowners, we can make this goal a reality. Missouri 811 is proactively participating in the 50-in-5 challenge by continuing to offer a wide variety of FREE training materials, online courses, and onsite excavation training with our Damage Prevention Managers. We encourage you all to stand with us in our goal to keep Missourians safer and our utilities functioning properly.





#### ENFORCEMENT -ATTORNEY GENERAL

It is the responsibility of the Missouri Attorney General's office to take action on member utilities and excavators who do not comply with the Missouri Underground Facility Safety and Damage Prevention Act, RSMo Chapter 319.010-319.050.

This enforcement of the law may result in warning letters and penalties for the member utilities and excavators, issued by the Attorney General's Office.

If you feel there has been a violation to Chapter 319, be sure to document as much of the incident as possible such as date, time, address, name of company, person or persons involved, etc. If possible, take photographs of the incident.

#### **Utility Violations:**

Attorney General of Missouri - Enforcement of the Missouri Underground Facility Safety and Damage Prevention Act (One Call Law) - Complaint Form and Checklist

If you believe you have witnessed a violation of the Missouri Underground Facility Safety and Damage Prevention Act, please report these violations to the Attorney General's One-Call Unit.

All this information is highly important for the one call system to operate correctly for you!




We have found that many of our contacts are elected officials and are replaced frequently. This could be our primary point of contact, mapping or billing contact, or even where tickets are being delivered.

## THE BEAD PROGRAM AND THE POTENTIAL EFFECTS ON MISSOURI INFRASTRUCTURE

The Broadband Equity, Access and Deployment (BEAD) program is bringing \$1.7 billion in funds to expand reliable access to the internet to all Missourians, especially areas that have been previously unable to obtain internet access. With the influx of fiber lines to be installed throughout the state, the

role of safe digging becomes even more crucial. As contractors are awarded jobs for installing the fiber lines and begin excavation, the financial and legal implications become quite significant. In an effort to reduce the risks of financial and legal liability for internet service providers, Missouri 811 offers a variety of training options for excavators at no cost. These training options include online and in-person training. The topics covered throughout these training sessions include: One Call law, Missouri's rules and regulations, marking standards, industry best practices, excavation safety and more.

The BEAD program is a great opportunity for Missourians across the state to have access to the internet, which has the potential to help many achieve their educational and business goals. However, the success of this program hinges greatly on these fiber lines being installed safely and without damage to existing buried utilities. By ensuring that all excavators are trained in safe and effective excavation practices, Missouri 811 is helping to ensure existing buried utilities remain functional and undamaged, as well as encouraging more efficient and timely installation of this valuable infrastructure.

#### LEARNING MANAGEMENT SYSTEM

Missouri 811's Learning Management System (LMS) continues to expand. Within our LMS, you currently have the option of taking any of three courses:

- Damage Prevention Awareness in English
- 2. Damage Prevention Awareness in Spanish
- 3. Essentials for Locators

The Damage Prevention courses are tailored for those who may be undertaking excavation activities. This course will teach you how to safely excavate near facilities. Participants will learn all about Missouri's excavation laws, regulations and industry best practices. The course is roughly an hour and a half long and is divided into 7 micro modules that discuss different stages of excavation. There are short quizzes throughout. Once a participant completes the course, they will receive a certificate of completion.

The Essentials for Locators Training is designed to educate utility locators who may be new to the field or who need a refresher. In this course, participants will receive an overview of 811 operations, get an in-depth look at the One Call Process, get a glimpse into locating principles and terminology, and receive on-site training with a locator using 360VP technology. This training is approximately an hour long and is divided into 4 modules. Upon successful completion, you will receive a certificate of completion.

By taking advantage of these great courses, you step up your knowledge and help keep Missouri's buried utilities running smoothly. In addition, you can ensure that everyone goes home safely.
